Fish Penalty: A fish that appears altered or mangled shall be the tournament director's decision to submit or not to submit that fish to the limit for the event. 13. Life Preserver: During any NEBKS events, contestants not wearing their life jackets zipped and secured during the entire event will have that day's eath disqualified from the tournament. 14. Ties: In case of a tie for length at any place at the end of the tournament, the angler with the biggest fish for that event will win. If still a tie, it will go to the first angler to submit his or her catch from the time of the picture will win and the same for each additional place thereafter as a stated above. Split linker of the event will be split if there is a tie for lunker. 15. No Live Bait: Only artificial lures can be used in any NEBKS event. The use of pork rind is permitted. 16. Trolling lures, even if the angler is not holding the rod, will be considered "in use." All bass must be caught live and in a conventional sporting manner. If a competitor breaks his line while setting the hook or retrieving a fish, he is allowed to make an attempt with the rod being used or by hand to secure the line and land the fish to be counted as legal. Anglers may NOT hook the line with another lure, rod and reel, or other device. If a competitor breaks his line will landing a bass he MAY use another rod and reel to retrieve the lost outfit. If that rod and reel is verified to be the lost outfit that bass may be landed and counted as a legal fish. Anyone guilty of snatching or snagging visible fish will have their catch disqualified. 17. Sportsmanship: All contestants are required to follow high standards of sportsmanship, courtesy, conservation and honesty. Drunkenness/drugs shall be cause for immediate disqualification. No alcoholic beverages or illegal drugs shall be allowed in the boats during the tournament hours extending through the close of the weigh-in.
